August is usually a quiet month for news – except for this year. The Berwick patient safety report was published, £500m is to be made available to address A&E pressures over two years. The Friends and Families Test has commenced for hospitals, so has Care Connect to capture complaints and compliments. There is more funding for research and innovation. There is news of a Surreywide remote monitoring programme, however, the Telehealth Forum survey suggests few people in the UK have heard of 'telehealth'. Videos and presentations from the recent Kings Fund Congress are now available. There are two new systematic reviews of telehealth and reports from the Birmingham OwnHealth programme. There was extensive UK (and worldwide) interest in the recent BBC2 programme on self-tracking called 'Monitor Me' – you can review it on You Tube. Autumn looks to be full of health and care activity with announcements around the integrated care pathfinders, progress on the Integrated Customer Service Platform and development of social care reforms.

There are two supplements this month covering 800 Web links and recent journal articles.

# Item 1 – News from ALIP (Assisted Living Innovation Platform), the Knowledge Transfer Network (HealthTech and Medicines KTN) and dallas

# (i) Better Plan – designed for well-being

Andrew Chitty, Founder and Chief Executive of Digital Life Sciences, and Davie McGirr, Director of Product Design, did a presentation on the <u>A Better Plan</u> app at a recent conference hosted by Birmingham City University on Wednesday 24 July, 2013.



"You don't need to convince me of the benefits of this app," said one member of the audience, during the question time, which lasted for more than half an hour and ran into the coffee break.

All the people who asked questions appreciated the concept of people taking control of their health through making their own care plans and being able to share them. Most of their feedback was about how A Better Plan could be developed or applied.

# (ii) Living it Up

A pop-up Living it Up shop has been set up in Stornoway, Scotland to find out from local residents how health, care and wellbeing services could be improved with the use of familiar technology.

The shop, part of the <u>Living it Up</u> (LIU) project in the Western Isles, was opened in June and has already engaged with more than 300 local people.

Living it Up, the Scottish <u>dallas</u> project, is being trialled in 5 regions - Western Isles, Moray, Highland, Lothian and Forth Valley. It is initially aimed at people over the age of 50 and will be of particular interest to carers, people living with long term health and care conditions or those that just want to ensure they keep happy, healthy and safe.



It will deliver new and integrated health, care and wellness services, information and products via familiar technology, enabling people to better care for themselves and others. These technologies will include TV, mobile phones, games consoles, computers and tablets.

LiU Western Isles Project Manager, Mary Sinclair, explained: "NHS Western Isles, in partnership with Comhairle colleagues, is currently recruiting 1,100 local participants to LIU to tell us about the technology they use in their daily lives.

"So far we have engaged with more than 300 people who have come into the shop to discuss, and find out, information on a range of subjects, including finding out what technology products are available and how to use them, information on connecting to local groups or people who share similar interests in crafts, photography, cooking, etc.

"We have also organised a range of technology workshop sessions that local people have asked for. These workshops were really varied and included: Social Media, Introduction to Tablets, Web Browser Settings, Digital Photography and Healthy Eating.

"Through the project, we will be developing solutions to issues, in terms of access to health and social care services, identified by our participants, and will be looking at where technology solutions could be maximised to their full potential. This is all about keeping people connected, which is key to avoiding isolation and the associated problems. The more input people have into developing new ideas and solutions; the better and more appropriate the solutions will be. Solutions will be designed to fit the lifestyles of the users - in their homes, communities or organisations - and will be attractive and usable".

# (iii) Ambient Assisted Living (AAL) Forum in Sweden (24-26 September 2013)

As part of the continued Knowledge Transfer activity for the Assisted Living Innovation Platform, the <u>KTN</u> will be attending and exhibiting at the 2013 <u>AAL Forum</u>.

We are offering support to the projects working on the Economic and Business Modeling, Social Behavioural Studies areas the opportunity to attend and use our exhibition area to display project activity.

# (v) AKTIVE

The AKTIVE project aims to explore the use of telecare in the everyday lives of older people experiencing memory problems or who are prone to falls. One part of the project is called <u>Everyday</u> <u>Life Analysis</u>, a research method involving interviews with older people using telecare. Older people are now being recruited into the study (through local authority telecare services and a health trust) in two locations, Leeds and Oxfordshire. It is intended that approximately 30 households will be recruited in each location. **Read the full article <u>here</u>**.

The King's Fund held its third annual congress on telehealth and telecare in London in July 2013.

Item 3 - Kent Care in the Digital Age event

A July 2013 event, Kent Care in the Digital Age (#KentDigiCare) provided an opportunity for 150 people from diverse organisations across the county including users and carers to come together to explore how technology can support and improve care services. The event was organised by James Lampert together with the Connected Care Network. The aim was for every participant to make at least five new connections and learn about five new technology innovations that would enhance care in their communities and take back learning points to share with colleagues in the workplace and community connectors and builders. The event was live streamed and tweeted so that a wider audience interested in the programme could take part in the discussions.

# Item 4 – UK policy announcements

Here is a roundup of UK policy news over the last month. A fuller listing is available in the supplement (doc, pdf).

(i) <u>Professor Don Berwick</u>, an international expert in patient safety, was asked by the Prime Minister to carry out a review following the publication of the <u>Francis Report</u> into the breakdown of care at Mid Staffordshire Hospitals. The <u>Berwick Report</u> highlights the main problems affecting patient safety in the NHS and makes recommendations to address them.



The report (press release and NHS England coverage) says that the health system must:

-recognise with clarity and courage the need for wide systemic change

-abandon blame as a tool and trust the goodwill and good intentions of the staff

-reassert the primacy of working with patients and carers to achieve health care goals

-use quantitative targets with caution - they should never displace the primary goal of better care -recognise that transparency is essential and expect and insist on it

-ensure that responsibility for functions related to safety and improvement are established clearly and simply

-give NHS staff career-long help to learn, master and apply modern methods for quality control, quality improvement and quality planning

-make sure pride and joy in work, not fear, infuse the NHS

(ii) Health Minister, Lord Howe has <u>announced</u> a £124m investment through the National Institute for Health Research (NIHR) for 13 teams (CLAHRCs) to ensure patients benefit from innovative new treatments and techniques – areas to be covered include dementia, COPD, stroke, diabetes, reducing A&E pressures.

(iii) A new NHS Procurement Development Programme <u>aims</u> to help the NHS save £1.5 billion by 2015 to 2016.

The programme sets out 4 major actions:

- achieving immediate efficiencies and productivity gains
- improving data, information and transparency
- improving outcomes at a reduced cost through clinical procurement review partnerships
- improving leadership and capability of procurement in the NHS

The report also gives examples of how money can be saved in the main NHS spending areas.

(iv) The UK is <u>hosting</u> the first G8 summit dedicated to seeking international coordination and an effective response to tackling dementia. In the UK, there are likely to be nearly a million people with the condition by the end of 2020. The government began a national <u>programme</u> of action through the Prime Minister's Dementia Challenge which launched in 2011. (In addition, Jeremy Hunt <u>talks</u> about using the G8 summit on dementia to seek further international collaboration).

(v) The Department of Health invited local areas to express an interest in becoming integrated care

pioneers in May 2013. A panel of experts will shortly <u>review</u> over 100 applications received. An announcement is expected in September 2013.

(vi) The Prime Minister has <u>announced</u> £500 million over the next two years to relieve winter pressures on A&E services in England. The new funding will go to A&E departments identified as being under the most pressure. The aim is for patients to be treated promptly, with fewer delays in A&E, and for other patients to get the care, prescriptions or advice they need without going to A&E (NHS England <u>coverage</u>).

(vii) <u>Directions</u> have been issued to the Health and Social Care Information Centre (HSCIC) to develop or operate NHS Choices online services information or communications systems.

(viii) NHS England has launched a new online service in parts of London (16 areas) and North East England (2 areas) called '<u>Care Connect</u>'. The new system led by Tim Kelsey (@tkelsey1, National Director for Patients and Information) allows people to report a problem, ask a question or share experiences of the health service in England. Comments and observations are sent directly to the organisations concerned for action and improvements. The single point of action response time for questions is an online answer within 24 hours.

(ix) From 20 August 2013, <u>legislation</u> came into force in England allowing physiotherapists and podiatrists to be able to independently prescribe relevant medication for their patients following a training course.

Examples include: Physiotherapists – treatment for pain and inflammation Podiatrists – treatment for diabetic foot ulcers and arthritic disorders

(x) NHS England is <u>looking</u> for views on 'Improving general practice – a call to action'. NHS England believes that GP practices will need to transform because of a number of challenges that include:

- (a) an ageing population, growing co-morbidities and increasing patient expectations, resulting in large increase in consultations, especially for older patients, e.g. 95% growth in consultation rate for people aged 85-89 in ten years up to 2008/09. The number of people with multiple long term conditions set to grow from 1.9 to 2.9 million from 2008 to 2018;
- (b) increasing pressure on NHS financial resources, which will intensify further from 2015/16;
- (c) growing dissatisfaction with access to services. The most recent GP Patient Survey shows further reductions in satisfaction with access, both for in-hours and out-of-hours services. 76% of patients rate overall experience of making an appointment as good;
- (d) persistent inequalities in access and quality of primary care, including twofold variation in GPs and nurses per head of population between more and less deprived areas;
- (e) growing reports of workforce pressures including recruitment and retention problems.

The initiative forms part of the wider '<u>The NHS belongs to the people: a call to action</u>' that NHS England launched on 11 July 2013. Various resources are available and the survey is open for feedback and comments until Monday 30 September 2013.

(xi) The Local Government Association and NHS England have <u>published</u> their planning 'vision' for how the pooling of £3.8 billion of funding, announced by the Government in the June spending round, will ensure a transformation in integrated health and social care. The 'Integration Transformation Fund' is a single pooled budget for health and social care services to work more closely together in local areas that takes full effect from 2015/16. The aim of the fund is to be an important catalyst for change with more preventative and community-based care.

(xii) Over 760 applications (total over £650m) have been <u>received</u> for the Safer Hospitals, Safer Wards Technology Fund which offers NHS Foundation Trusts and NHS Trusts access to a £260 million technology pot of money to support rapid progression from paper-based systems for patient notes and prescriptions to integrated digital care records and the development of ePrescribing.

(xiii) NHS England's Tim Kelsey and Beverley Bryant are holding a further <u>event</u> on 11 September 2013 for health technology start-up companies and SMEs. The aim is to provide an opportunity to meet the NHS England team and find out how NHS England is supporting entrepreneurs. It includes a briefing on the new Academic Health Science Networks (AHSNs) and whether there will be funding for health technology innovations.

xiv) The <u>NHS Innovation Challenge Prize for Dementia</u> in Collaboration with Janssen Healthcare Innovation closes midday 4 September 2013. Health and care professionals are invited to demonstrate the delivery of a comprehensive integrated service across health, care and support for people with dementia to win £150,000. (xv) The NHS England website has an Interesting <u>article</u> by <u>Alistair Burns</u> on 'The number of people with dementia in England: turning the tide'.

(xvi) <u>Registration is now open</u> for anyone with an <u>interest</u> in the work of the Specialised Services Clinical Reference Groups (CRGs). CRGs have been established to cover the range specialised services defined within NHS England's mandate. These services are generally provided by specialist hospitals, serving a catchment population of more than one million people. The programmes of work for specialised services are structured around 74 CRGs under five Programmes of Care:

-Internal Medicine

- -Cancer and Blood
- -Mental Health
- -Trauma
- -Women and Children

(xvii) NHS England is currently <u>reviewing</u> the local allocation of resources across the full range of its responsibilities, covering both allocations to CCGs and the budgets available for direct commissioning functions in area teams – four regional workshops are planned for September 2013. (<u>Press release</u>)

(xviii) NHS England has <u>published</u> details about a new £50m innovation evaluation fund, specifically focused on those prescribed specialised services which it is responsible for directly commissioning. The Specialised Services Commissioning Innovation Fund (SSCIF) will transform the way that new innovations are identified, tested and adopted. The fund will open for business on 2 September 2013. It is anticipated that innovations will cover a diverse range of areas including care pathways, workforce, technologies, devices and diagnostics. Applicants are expected to include manufacturers, patient groups, voluntary sector organisations, commissioners, NHS frontline staff and non-NHS service providers.

(xix) NHS England has a new You Tube video called 'Putting Patients First'.

(xxi) NHS England is to <u>oversee</u> the transition to new providers of NHS 111 services as NHS Direct gradually withdraws from contracts.

(xxii) Do you have ideas about how to improve care for vulnerable older people? – The DH <u>consultation</u> runs until 27 September 2013.



(iv) Surrey County Council has commissioned a major telehealth programme from Medvivo (@Medvivo news) covering all six clinical commissioning groups and up to 1500 COPD and heart failure patients over three years (<u>Pulse</u>, <u>EHI</u> and <u>MedVivo Press Release</u>).

(v) There is further <u>coverage</u> (from Pulse) for the Airedale Hospital Telehealth/Telemedicine Hub and its support for patients in their homes as well as in residential and nursing homes. (Also, more from the <u>local press</u> on Airedale Hospital meeting A&E targets).

(vi) WHO Health Literacy – new report



"The recent European Health Literacy Survey found that nearly half of all adults in the eight European countries tested have inadequate or problematic health literacy skills that adversely affect their health literacy. Weak health literacy competencies have been shown to result in less healthy choices, riskier behaviour, poorer health, less self-management and more hospitalization. They significantly drain human and financial resources in the health system." The WHO <u>report</u> addresses the issue.

(vii) There is a new Charter Institute of Housing <u>report</u> on Care for Older People commissioned by the Joint Improvement Team in Scotland.

(ix) What will be the key trends in the mobile health market over the next four years – some <u>insight</u> from 324 opinion leaders.

(X) The Pew Research Center's Internet & American Life Project has been studying online adults' social networking site use since 2005, and has seen substantial growth since then. Today, 72% of online adults use social networking sites. How are using social media to raise awareness, share news and good practice around telehealth and telecare services?

(xii) A recent <u>survey</u> commissioned by <u>Invicta Telecare</u> showed that people aged over 65 feel that the terms 'old' and 'elderly' have become both negative and offensive and believe that their generation is sometimes ignored or treated disrespectfully because of their age. 65 per cent of older people interviewed also admitted that they have not seriously thought about the type of care they might need as they get older, and worry about becoming a burden to friends and family members in the future.

(xiii) <u>Plans</u> to transfer community alarm services run by housing associations to One Connect Limited have been scrapped by Lancashire County Council.

(xiv) Want to know which AHSN is covering your area – here is a <u>map</u>. Never heard of an Academic Health Science Network – <u>here</u> is an explanation. Of course there are also <u>CLAHRCs</u> and here is a Guardian <u>map</u> of the 211 Clinical Commissioning Groups in England.

(xv) Alzheimer's Society has published a booklet to provide information and advice to all people diagnosed with dementia and their families or carers.



The <u>dementia guide</u>, which is part-funded by the Department of Health, is designed for healthcare professionals to offer to people recently diagnosed with dementia.

(xvi)The FDA has <u>issued</u> 'Radio Frequency Wireless Technology in Medical Devices' - Guidance for Industry and Food and Drug Administration Staff.

(xvii) There are continuing <u>issues and concerns</u> over Australia's eHealth and electronic health record arrangements.

(xviii) There is <u>speculation</u> that Samsung will announce their smartwatch on 4 September 2013.

(xix) If you are looking at predictive risk modelling for local populations, Nuffield Trust is always a good resource – here is a <u>video</u> from a recent conference.

(xx) Pulse <u>reports</u> on the GPC warning that the Telehealth DES (21p per patient) reporting requirements could lose practices money.

(xxi) Is the Dementia rate falling? – Forbes looks at recent studies in England and Denmark to try and understand what is happening.

(xxii) It remains unclear whether or not smart metering will have other features (eg telehealth/telecare/internet) as the programme gets rolled out across the UK but contracts are being awarded for the nationwide roll out (<u>announcement</u>).



(xxiii) Med City News <u>reports</u> on Medtronic's acquisition of Cardiocom's Telehealth service – a significant development in the U.S.

(xxiv) The implementation of the Government's new social care policies will be a major piece of work over the next few years, Mithran Samuel at Community Care has an excellent Care Bill <u>reading list</u>. Also from <u>Community Care</u>, councils will have to protect access to social care to access £2bn in transferred funding from the NHS designed to promote integrated care. The DH is working with LGA and NHS England to work out the arrangements.

(xxv) Making sense of public data - "Over 2.4 million people in England or about **5.5%** have diabetes. On average £24.45 is spent per diabetes patient per month on prescriptions to treat their condition" - the CDEC <u>Open Health Data Platform</u> is leveraging data from a number of sources. Analysis of big data could be very important for management of health and wellbeing in local populations.



(xxvi) on 3 September 2013, Contour Homes in conjunction with Trafford Housing Trust and Tunstall Healthcare are running an all day drop-in event that will include a series of workshops and a keynote speech delivered by Rt Hon Hazel Blears, MP for Salford and Eccles and vice chair of the All Party Parliamentary Group on Dementia. Find out <u>more</u>.



(xxvi) Richard Vize in the Guardian <u>writes</u> on how bringing together every part of a community can boost quality of life for people coping with dementia – <u>creating</u> a dementia friendly Crawley. He also has a Guardian <u>article</u> on telehealth and the Whole System Demonstrator Programme reports.

(xxvii) The <u>question</u> about whether diabetes test strips are being restricted has come up again in the NHS in England (also covered in <u>Telegraph</u>). Meanwhile, some test strips have been <u>recalled</u> over concerns about false readings.

(xxviii) From <u>eHealth Insider</u>, NHS England has issued a tender worth up to £2m to train 100,000 people - the 'Health Online Programme' aims to improve the way people interact with health services. Another programme, Code4Health will be launched later this year to support patients and doctors on coding and app development.

(xxix) eHealth Insider <u>reports</u> on the development of the '<u>myhealth@QEHB</u>' patient portal at University Hospitals Birmingham NHS Foundation Trust. The portal allows patients to view and update their own medical records such as medication, test results, discharge letters, and details provided in clinical appointments online. The trust also plans to connect the portal to telehealth devices which will direct questionnaires to patients to monitor their symptoms, vital signs and treatment compliance.

(xxx) From <u>eHealth Insider</u>, Health secretary Jeremy Hunt has asked the Health and Social Care Information Centre to provide a plan "for reducing bureaucracy and burden that diverts valuable resources away from the delivery of safe, and compassionate care." The Centre is launching a 'Let's Bust Bureaucracy Together' campaign in October 2013 including establishing a single dataset and moving towards an electronic patient record. Meanwhile an <u>expanded set</u> of social care data is due to be collected and published annually by the Health and Social Care Information Centre – councils will get an additional £11.8m to fund collection of the new dataset.

(xxxii) EHI also <u>reports</u> that Northern Devon community health staff are using Samsung tablets to electronically record more than 9,000 patient contacts a week. More than half a million appointments have been created to date, with 9,000 contacts entered by more than 130 teams weekly.

(xxxiii) Expectations are that the <u>integrated customer service platform</u> (ICSP) being developed by NHS England could save more than £1 billion by encouraging online self-care, so reducing face to face and paper transactions. ICSP would be the main portal for health, public health and social care using phone, texts and online content. A November 2013 launch is planned to include a symptom checker (linked to NHS Choices) GP appointment booking, a health apps library, web chat, tools to find the nearest urgent care provider and GP and online ordering of repeat prescriptions.

(xxxiv) A You Gov <u>survey</u> commissioned by Telehealth Forum suggests that only one in ten people have heard of telehealth and less than half of this group know what it is.

(xxxv) The Commons health select committee <u>suggests</u> that deprivation of liberty safeguards which are supposed to ensure dementia sufferers are protected are not working because some care providers simply ignore them.

(xxxvi) There's controversy again over NHS health checks – In a recent GP Online <u>survey</u>, less than a quarter of GPs think the NHS should offer health screening and one in ten will refuse to offer the checks this year.

(xxxvii) Fitness devices and apps are now big business with a new \$43m funding round – but so has some of the competition such as Withings (\$30m) and MyFitness Pal (\$18m) – Tech Crunch has the story.

(xxxviii) In the Journal of General Practice, Professor Trisha Greenhalgh <u>sets out</u> five biases of new technologies in medicine

- 1. Pro-innovation bias
- 2. Subjunctivisation bias
- 3. Bells and whistles bias
- 4. Connectivity bias
- 5. Human substitution bias

(xxxix) A new <u>report</u> (Rethinking the Integration Agenda) published by the Good Governance Institute (GGI) highlights how the successful integration of health, housing and social care services is crucial to the creation of sustainable care models for the future. The report draws on the experience of 16 leading experts and sets out three barriers to overcoming barriers to integration:

- 'Living Well' pathways should inform attitudes towards care services
- Developing new cultures of care
- Investment in new enabling technologies



(xl) From <u>Pulse</u>, GPs will be allowed to use home BP monitoring instead of having to invest in ambulatory monitors under a redrafted QOF indicator recommended by NICE.

(xlii) ex-care services minister Paul Burstow is leading a <u>commission</u> to investigate the future of residential care. The Commission is looking to answer a number of questions - How do you define residential care? Do you see extra care, retirement villages and other "housing with care" options as different by definition? What makes them different?

(xliv) Information week has an article on Remote Patient Monitoring: 9 Promising Technologies



(xlv) ONS data <u>indicates</u> that there is No internet access in 17% of UK homes. Three-quarters of the UK's adults access the web daily, with mobile browsing growing most quickly. Just over half of all adults accessed the internet on their phones - more than double the total in 2010. The ONS data suggested that more than a third of over 65s are now online, but Age UK has warned there is still crucial work to be done in this area. ONS data also <u>indicates</u> that the UK has the fastest growing population in Europe.

(xlv) There is a new MedVivo telehealth <u>video</u> from Dorset on You Tube.



(xlvi) Indications are that the <u>final version</u> of the Telescope Code of Practice on telehealth will be available in September 2013.

(xlvii) <u>Entry</u> is now open for this year's Crystal Award to be announced at the Telecare Services Association's annual conference in November 2013.

(xlviii) A scheme based at the Royal Free Hospital allowing people to go home even when they are still acutely ill is being extended to more patients – find out <u>more</u>.

(xlix) There will be a shortfall in the number of people able to provide vital unpaid care to frail elderly people in the coming years, a <u>report</u> says. The LSE analysis suggests the gap will start becoming evident by 2017 in England and by 2032, 160,000 elderly people will be left without the support they need - about one in seven of those who will need help. Meanwhile, Jeremy Hunt says there must be a change of attitude among employers offering flexible working if the country is to cope with the 'dementia time bomb'.

(I) Pulse <u>reports</u> that it is looking as though the Department of Health could be handing back a significant underspend on the 2012/2013 account back to the Treasury

(li) Accenture has <u>published</u> an eight country survey of Doctors that shows a significant increase in healthcare IT usage.

(lii) KPMG has published a new <u>report</u> 'An uncertain age: Reimagining long term care in the 21<sup>st</sup> century that covers approaches considered in a number of countries.

(liii) Communities Minister Don Foster has <u>announced</u> proposals to simplify confusing housing standards. Essential safety and accessibility rules will not be changed, but locally applicable requirements will be reduced from over 100 to fewer than 10 with a reduction in guidance from 1500 pages to fewer than 80 pages.
