## Some UK News Headlines this week

(i) Queen's Speech - extract

"In England, my government will secure the future of the National Health Service by implementing the National Health Service's own 5 year plan, by increasing the health budget, integrating healthcare and social care, and ensuring the National Health Service works on a 7 day basis. Measures will be introduced to improve access to general practitioners and to mental healthcare". (Queen's Speech)

(ii) Health Secretary, Jeremy Hunt has outlined his priorities in a post-election <u>speech</u> at the King's Fund. The NHS would receive the proposed £8bn a year, as outlined in the Conservative party's election manifesto, but this money was going to come from cuts to other government departments. In addition, the NHS would have to find £22bn of efficiencies.

(iii) Some UK patients will be able to send data such as exercise charts, blood pressure readings, and asthma information directly into their electronic records with the help of the free <u>Emis mobile app</u>.

(iv) Kian Saneii's U.S. company has <u>developed</u> a TV-based platform (Independa) where caregivers and family members can use a web portal or mobile app to video chat, send Facebook messages and photos, set up appointments/medication reminders and play games. The system can also interface with blood-pressure monitoring devices, scales and glucometers, and can serve as a door sensor and emergency-alert system.

(v) A new <u>report</u> from the Institute for Public Policy Research (IPPR) assesses progress made by local authorities in setting up 'Amazon-style' e-marketplaces to meet Care Act duties to provide choice for self-funders and personal budget holders.

(vi) The Wall Street Journal has an <u>article</u> on the value of under-mattress sensors in hospital beds to check vital signs such as heart rate and breathing as well as bed exits.

(vii) Web GP from the Hurley Group is <u>expanding</u> and could reach 2m UK patients over the next year.

(viii) From the U.S.: The VA is 'building' a <u>virtual medical centre</u>. The project brings together simulation training, telehealth and modern-day gaming technology and graphics.

(ix) A recent UK journal <u>article</u> considers that users need to be more involved in the development of technology services. Awareness needs to be raised using information about various technologies that need to be customisable and adaptable. The Authors also consider that services need to align with the individual's social support network and there needs to be a high degree of information sharing and coordination.

(x) Digital wellness and telemedicine platform Fruit Street Health has chosen Validic's digital health platform to access more than 175 wearable devices and applications into its telehealth software, personal health record and HIPAA compliant video conferencing platform.
