



## TELECARE & DEMENTIA SUPPLEMENT JANUARY 2014

Welcome to an additional supplement from the Technology Strategy Board (TSB) Knowledge Transfer Network and the Telecare Learning and Improvement Network.

This dementia supplement provides useful background information and resources for health, housing and care organisations particularly around supporting people, their families and friends. It contains links to national policies, reference sites and major initiatives. It follows the previous Telecare LIN [supplement](#) from September 2009.

All links have been checked during January 2014 but will no doubt change over time. The format is alphabetical with some cross-referencing. There are currently a number of developments in this area and it is always difficult to capture and list them all - further initiatives will appear in the monthly newsletter as usual.

It is a timely supplement following the recent G8 Summit, the forthcoming Care Bill and £3.8bn Better Care Fund in England as well as the publication of a new book on Living Well with Dementia by Shibley Rahman. The Housing LIN will also be looking at housing and dementia at their February 2014 conference.

Since the 2009 supplement there has been a growing interest in the use of sensors, wearables and apps in supporting people with dementia. It is a rapidly developing area where often the technologies have not yet been fully tested and evaluated. This means caution needs to be stressed when using some of the newer configurations. Where devices and systems are gathering data, it is important to consider where it is being stored and how it is being used to improve outcomes and quality of life for people with dementia, their carers and families.

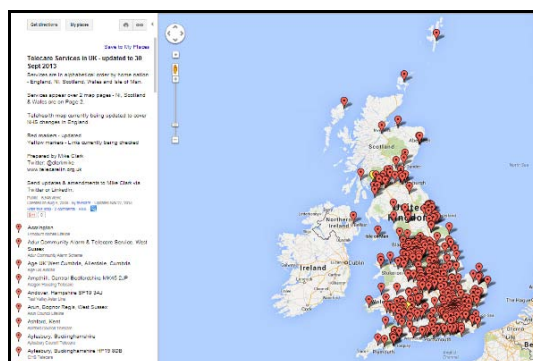

# A

## Access to local telecare services for users and carers

[Telecare services](#) in the UK can be located on the Google map. For local authorities providing social care services use the [locator](#). Local health and care professionals can help identify appropriate products and services that are available and that can help meet identified needs.

## Accident and emergency (A&E) and admissions

A December 2013 Sunday Express [inquiry](#) suggests 600 emergency admissions or readmissions are being made every day for people with dementia. The numbers quoted suggest 219,064 admissions in 2011/12 compared with 133,373 in 2007/08'. In April 2013, The [Guardian](#) reported that Care home residents with dementia were being sent to A&E alone. In October 2013, The National Audit Office [reported](#) that over one million A&E patients are being kept in hospital wards when they could have been treated at home. Admissions to A&E have increased by a third in the past decade and a quarter of patients who arrive in emergency departments are later admitted to a hospital ward. The NAO report warns that the NHS is wasting £2 billion each year treating patients in hospital wards when it could have been avoided. Alzheimer's Society [commented](#) that people with dementia occupy up to a quarter of hospital beds, have higher length of stays and readmission levels. Significant increases in the numbers of older people attending A&E by ambulance have been [reported](#) in January 2014. The New Cross Hospital in Wolverhampton (amongst others) has [looked](#) at the importance of the healthcare environment for the care of people with dementia including the A&E environment.

## Activity Monitoring

UK telecare and telehealth providers together with health and care professionals can advise on technologies and service support for activity monitoring in assessment, monitoring, smart home environments and safer walking (see separate entry - Access to Telecare Map).

Procurement frameworks (see separate entry) are in place which list suppliers. The Telecare Services Association (see separate entry) has a large number of organisations in its membership role.

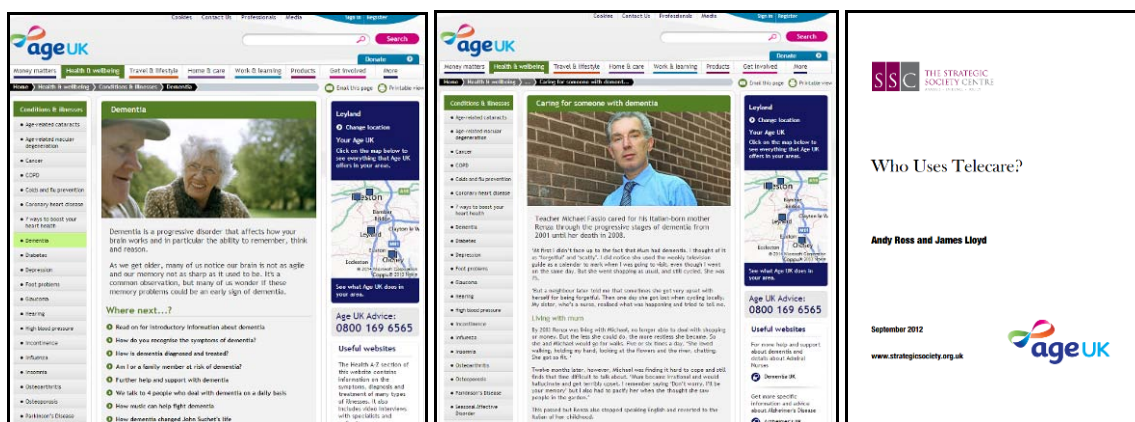

### Better Care Fund

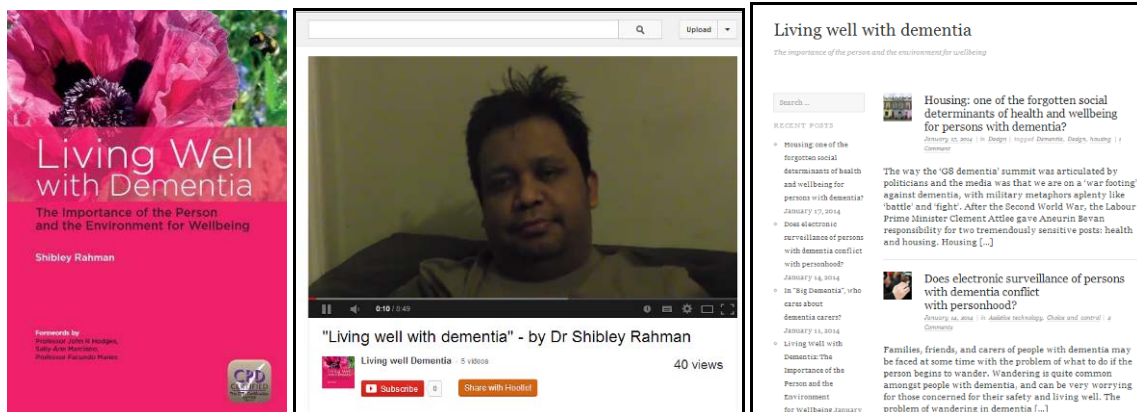
In 2015-2016, £3.8bn of existing health and care funds in England will be pooled across health and care services as agreed by 152 local health and wellbeing boards. Developments will include improved services for people with dementia and the use of a range of assistive technologies including telecare and telehealth. ## **Care Bill**

The [Care Bill](#) for England is currently going through the House of Commons. The Bill is subject to detailed scrutiny prior to report on 4 February 2014. The Department of Health has produced a number of [factsheets](#) covering the Bill. When enacted, the Bill will have a significant impact on the work of local authority social care services in England including prevention and wellbeing, clearer eligibility criteria and the provision of information and advice. It is expected that upwards of 500,000 self-funders will need to be assessed so that eligibility for services can be determined. Significant numbers of people with dementia are likely to go through assessment processes.

There have been numerous publications about the quality of care home environments, staff training, use of medication and other quality issues as well as better regulation and provision of comparative information to enable choices to be made.

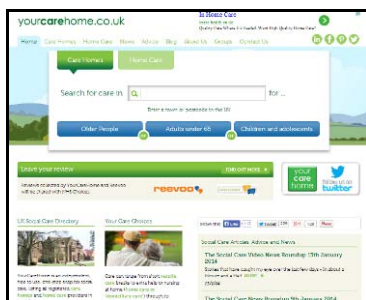

The Commissioning for quality and innovation (CQUIN) payment framework enables commissioners in England to reward excellence, by linking a proportion of English healthcare providers' income to the achievement of local quality improvement goals. The 2013/14 scheme included a [goal](#) as follows:

*'To incentivise the identification of patients with dementia and other causes of cognitive impairment alongside their other medical conditions, to prompt appropriate referral and follow up after they leave hospital and to ensure that hospitals deliver high quality care to people with dementia and support their carers'.*

In 2013, The Alzheimer's Society [published](#) 'Dementia 2013: The hidden voice of loneliness' which looked at the quality of life for people with dementia in England, Wales and Northern Ireland. It provides a snapshot of how well people are living with their dementia, what support they are receiving, and what barriers they face to living well.

Dementia 2013 also focuses on the impact of loneliness and social isolation on people living with the condition, particularly for those living alone. Nearly two-thirds (63%) of people with dementia surveyed said they felt anxious or depressed. A third of people with dementia said they had lost friends, and 5% said they have not told their friends about their diagnosis. Of those living alone, nearly two-thirds (62%) of people with dementia reported feeling lonely.

## Medication

In November 2009, the Government accepted the findings and recommendations of the independent [Banerjee Report](#) on the prescribing of antipsychotics for people with dementia. The report identified an unacceptable level of mortalities as a result of prescribing antipsychotics in people with dementia. The report makes several recommendations, mainly that people with dementia should receive antipsychotics only when they really need them, and that reducing their use in this group should be a priority for the NHS. It suggests this can be achieved by various means including training carers and medical staff to use alternatives to anti-psychotics. The report estimated that anti-psychotic use could be safely reduced to a third of its current usage over a period of three years. Since that point, a number of national reports have set out to address the issue of how medication is used appropriately in dementia care.

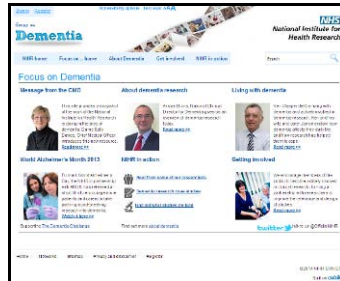

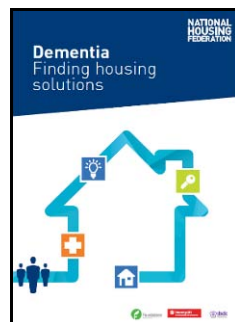



## **National Policies**

The scale of the dementia challenge has led to the development of policies across the UK.

### **England**

In February 2009, the Department of Health published '[Living Well with Dementia](#)' with 17 objectives across 3 key areas (improved awareness, earlier diagnosis and intervention, and a higher quality of care). The aim was to improve dementia services across England through local partnerships and dementia action plans.

In September 2010, the Department of Health published '[Quality outcomes for people with dementia: Building on the work of the national dementia strategy](#)'.

The change in Government in 2010 identified four priority areas for local action:

1. Good quality early diagnosis and intervention for all
2. Improved quality of care in general hospitals
3. Living well with dementia in care homes
4. Reduced use of anti-psychotic medication

In March 2012, the Prime Minister's [Challenge on Dementia](#) was published to deliver major improvements in dementia care and research by 2015. The challenge focuses on three areas;

1. Driving improvements in health and care
2. Creating dementia friendly communities (that understand how to help)
3. Better research

Five key commitments are made:

1. Increasing diagnosis rates
2. Financial rewards for hospitals offering quality dementia care
3. An innovation challenge prize
4. A dementia care and support compact for care homes
5. Improving information on local dementia services

The [NHS Mandate](#) (from the Government via the Department of Health to NHS England) states that the Government's goal is that the diagnosis, treatment and care of people with dementia in England should be amongst the best in Europe.

The policy context also brings the establishment of 211 Clinical Commissioning Groups, reforms of care services to promote independent, wellbeing, choice and control (Care Bill), more person/patient-centred approaches, Integrated Care and the Better Care Fund (£3.8bn pooled fund for 2015/16).

[Public Health England](#) has named dementia as one of its seven [high level priorities](#) for 2013/14.

The [Dementia Action Alliance](#) (DAA) is made up of over 900 organisations committed to transforming the quality of life of people living with dementia in the UK and the millions of people who care for them. Members of Dementia Action Alliance have signed up to a National Dementia Declaration. Other work includes the development of a [dementia care and support compact](#) and the creation of [dementia friendly communities](#).

The [Alzheimer's Society](#) is the UK's leading care and research charity for people with dementia and those that care for them. It provides information and support for people with all forms of dementia, runs local care services, gives advice to professionals and government and campaigns for improved health and social care and greater public understanding of dementia.

The Alzheimer's Society's campaign, [Dementia Friends](#) aims to give people in local communities an understanding of dementia and the small things they can do that can make a difference. The aim is to create a network of a million Dementia Friends across England by 2015.

Nine quality outcomes for people with dementia (2010):

By 2014, all people living with dementia in England should be able to say;

1. I was diagnosed early
2. Those around me and looking after me are well supported
3. I feel part of a community and I am inspired to give something back
4. I understand, so I make good decisions and provide for future decision making
5. I am treated with dignity and respect
6. I can enjoy life
7. I get the treatment and support which are best for my dementia and my life
8. I know what I can do to help myself and who else can help me
9. I am confident my end of life wishes will be respected. I can expect a good death

Commissioning for quality and Innovation (CQUIN) was introduced in 2009 to make a proportion of a healthcare providers' income conditional on demonstrating improvements in quality and innovation in specified areas of care. In 13/14 there is a national CQUIN for dementia for acute NHS service providers (see separate entry).

The Quality and outcomes framework (QOF) was introduced in 2004 as part of the General Medical Services Contract, the QOF is a voluntary incentive scheme for GP practices in the UK. It contains groups of indicators, based on quality standards, against which practices score points according to their level of achievement. In [2013/14](#) the following QoF indicators are included for dementia:

DEM001 - The contractor establishes and maintains a register of patients diagnosed with dementia

DEM002 - The percentage of patients diagnosed with dementia whose care has been reviewed in a face to face review in the preceding 12 months

DEM003 - The percentage of patients with a new diagnosis of dementia recorded in the preceding 1 April to 31 March with a record of full blood count (FBC), calcium, glucose, renal and liver function, thyroid function tests, serum vitamin B12, and folate levels recorded between 6 months before or after entering on to the register

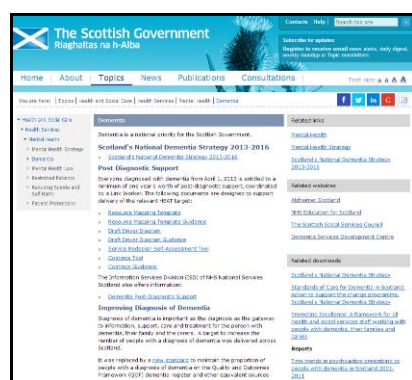
NHS England has produced an enhanced service specification for 2013/14 to reward GP practices for undertaking a proactive approach to the timely assessment of patients who may be at risk of dementia (see separate entry).

The G8 Summit in December 2013 had a particular focus on dementia (see separate entry).

The Department of Health has [summarised](#) additional funding to meet some of the aims and objectives.

In England, local dementia strategies are now linked with the work of Health and Wellbeing Boards through joint strategic needs assessments and health and wellbeing strategies.

**COMMITMENT 5:** We will take further action to support safe and supportive home environments and the importance of the use of adaptations and assistive technology, in maintaining the independence and quality of life of people with dementia and their carers.

- timely, accurate diagnosis of dementia.

- equal partners in care throughout the journey of the illness.
- better respect and promotion of rights in all settings, together with improved compliance with the legal requirements in respect of treatment.
- people with dementia in hospitals or other institutional settings always being
- treated with dignity and respect.

### Innovation Challenge Winners

Three services have been recognised as winners of the NHS [Innovation Challenge Prize](#) for Dementia. An integrated dementia service, Memory First has won the top prize of £80,000. Run by a consortium of 162 GPs across 41 practices in Staffordshire, the service has cut diagnosis times from two and a half years to four weeks, as well as major improvements in patient experience. Other winners - Greenwich Advanced Dementia Service (helping people to stay in their own homes for longer) and the Early Intervention Dementia Service in Worcestershire (already helped 2,000 people get a more timely diagnosis).
